This Tech Tip is to advise the introduction of new extra long life coolant at factory fill. The new coolant is designated "FL22". All current models will be progressively changed over to FL22 coolant for factory fill at production.

## **REASON FOR INTRODUCTION:**

- To reduce maintenance cost
- To reduce coolant waste and save resources

Note 1: FL22 will not be used in B4000 V6 cooling systems. B4000 uses L405F type coolant only (orange), part number B4V6-W9-00L5. Please refer to Parts Marketing Bulletin M11\_06 for more information about this coolant.

### **IDENTIFICATION OF VEHICLES WITH FACTORY FILL FL22**

Vehicles with factory fill FL22 will have an identifying label attached to the radiator cap (refer image at right).



### **COOLANT REPLACEMENT INTERVAL – COMPARISON OF PREVIOUS COOLANT TO FL22**

	Initial Fill (Factory)	Subsequent Fill (At Service)
Previous coolant	4 years / 80,000 km	2 years
FL22	10 years / 200,000 km 5 years / 100,000 km	

## FL22 COMPATABILITY WITH PREVIOUS COOLANT

The new FL22 is compatible with the previous coolant. However, as both coolants are green, it is not possible to visually distinguish between them.

## COOLANT REPLACEMENT INTERVAL WHEN COOLANT TYPE IS CHANGED DURING SERVICE

Coolant Type in System	Coolant Used for refill	Replacement Interval	Comment
Previous coolant	FL22	5 years / 100,000 km	Attach "FL22" sticker close to radiator or coolant reservoir
FL22	Previous Coolant (K300-W9-00L1 or K300-W9-00L20)	2 years	Blank out underbonnet "FL22" sticker with black marker

### **COOLANT TOP-UP**

We recommend using FL22 for top up of cooling systems containing FL22. However the system may be topped up with previous coolant (K300-W9-00L1 or K300-W9-00L20) up to 5% of system capacity without shortening the replacement interval. If top up is more than 5%, the replacement interval reverts to 2 years.

#### **AVAILABILITY**

- FL22 is available through normal parts channels, part number K018-W0-12220L (20 litre container).
- FL22 stickers ("Next Replacement Date and Kms"), which can be attached to the coolant reservoir
  of vehicles in the event of retrofill with FL22, are now available. See the next page for an image of
